1. The normal trading terms of Allstock Nominees Pty Ltd are COD payment by Cash, Cheque or Direct Deposit. Credit Card payment is accepted on COD accounts at 2.5% extra charge.
2. A Credit facility may be provided to approved Applicant's only, sufficient Credit References must be provided. It is understood that any credit facility which may be granted to the Applicant is granted only at their request and in consideration that they guarantee payment of all sums payable by the Applicant to Allstock Nominees Pty Ltd. A 2.5% charge will apply when paying credit accounts by credit card.
3. I/We acknowledge and agree that the terms of Payment are "Strictly 7 Days after end of month". In the event the account becomes overdue, Allstock Nominees Pty Ltd reserves the right to charge interest in accordance with the Penalty Interest Rates Act 1983.
4. Allstock Nominees Pty Ltd at its discretion, reserves the right to refer the overdue account to a mercantile agency or a solicitor for collection and recovery action and I/we agree to be responsible to meet all reasonable costs and commissions incurred in employing a mercantile agent or solicitor to collect the overdue amount.
5. Agreement that Allstock Nominees may seek consumer credit information (Section 18K(1)(b), Privacy Act 1988)
 If Allstock Nominees considers it relevant to assessing my/our application for commercial credit, I/we agree to Allstock Nominees obtaining from a credit reporting agency a credit report containing personal credit information about me/us in relation to commercial credit provided by Allstock Nominees.
6. Exchanging information with other credit providers (Section 18N(1)(b), Privacy Act 1988)
 I/we agree to Allstock Nominees obtaining personal information about me/us from other credit providers, whose names I/we may have provided for Allstock Nominees or that may be named in a credit report, for the purpose of assessing my/our application for commercial credit made to Allstock Nominees.
7. Agreement to a credit provider being given a credit report to collect overdue payments on commercial credit (Section 18K 1(h) Privacy Act 1988)
 I/we agree that Allstock Nominees may obtain a consumer credit report about me/us from a credit reporting agency for the purpose of collecting overdue payments relating to commercial credit owed by me/us.
8. The Applicant(s) must inform Allstock Nominees Pty Ltd in writing within seven (7) days of any change of his/her/their business or corporate structure.
9. Allstock Nominees Pty Ltd reserves the absolute right to refuse or withdraw the Applicant(s) credit facilities at any time in its sole discretion this may include accounts that are left non-active for a period greater than 6 months or trade less than \$5,000 per month.
10. All contracts between Allstock Nominees Pty Ltd and the Applicant shall be deemed to have been entered into in the State of Western Australia and shall be construed according to the Laws of the State Western Australia
11. Allstock Nominees Pty Ltd reserves the following rights in relation to any goods provided to the Applicant by Allstock Nominees Pty Ltd, until all accounts owed by the Applicant to Allstock Nominees Pty Ltd are fully paid:
 - (1) legal ownership of the goods;
 - (2) to enter the Applicants premises (or the premises of any associated company or agent where the goods are located) without liability for trespass or any resulting damage and retake possession of the goods; and
 - (3) to keep or resell any goods repossessed pursuant to (2) above;
 If the goods are resold, or products manufactured using the goods are sold, by the Applicant, the Applicant shall hold such part of the proceeds of any such sale as represents the invoice price of the goods sold or used in the manufacture of the goods sold in a separate identifiable account as the beneficial property of Allstock Nominees Pty Ltd and shall pay such amount to Allstock Nominees Pty Ltd upon request. Notwithstanding the provisions above Allstock Nominees Pty Ltd shall be entitled to maintain an action against the Applicant for the purchase price and the risk of the goods shall pass to the Applicant upon delivery.
12. Any signatory for a proprietary Company Applicant shall be personally liable for the due performance of the Applicant's obligations as if the signatory was the Applicant.
13. Orders placed with Allstock Nominees Pty Ltd and accepted after signing the Allstock Nominees application will be accepted strictly subject to these conditions of sale and the placing of such orders shall be conclusive of the fact that the Applicant has read, understands and agrees to such conditions of sale.
14. Delivery will be made to the location specified on the order form and the Applicant shall be liable for freight and handling charges.
15. Allstock Nominees Pty Ltd will endeavour to fill all orders promptly but will not be liable in respect of any delay occurring in the supply of the goods and/or services or any loss or costs the Applicant may suffer as a result. Allstock Nominees Pty Ltd shall not be liable for indirect or consequential loss or any loss to Applicant(s) due to the delay.
16. Claims for short delivery or goods damaged in transit must be made in writing to Allstock Nominees Pty Ltd within seven (7) days from the date of invoice, claims after this period will be rejected by Allstock Nominees Pty Ltd.
17. Allstock Nominees Pty Ltd offers Warranty on all new Hardware supplied, for use in Australia only. This warranty does not extend to accessories or defects or injuries caused by or resulting from causes not attributable to faulty parts or the manufacture of the product, including but not limited to, defect or injury caused by or resulting from misuse, abuse, neglect, accidental damage, improper voltage, liquid spillage, pest infestation, software or any alterations which are not authorised by Allstock Nominees Pty Ltd. Warranty repairs are to be returned to Allstock Nominees for repair, insurance and freight prepaid, with appropriate paperwork including copy of original invoice and completed RA form. Please contact our Sales Department to confirm warranty period on particular products. The Applicant acknowledges that Allstock Nominees Pty Ltd is a distributor not a manufacturer and the warranty offered by Allstock Nominees Pty Ltd is a reflection of the warranty offered by the manufacturer. Goods returned to Allstock Nominees Pty Ltd as part of a warranty claim shall be onforwarded by Allstock Nominees Pty Ltd to the manufacturer for assessment and either rejection of the warranty claim or repair or replacement in accordance with the applicable manufacturer's warranty.
18. Allstock Nominees Pty Ltd request that all Purchase Orders be faxed or emailed to our Sales Department, therefore no responsibility is taken for errors with any orders placed by telephone. Re-stocking fee or refusal of claim will apply to any errors with telephone orders.
19. Allstock Nominees Pty Ltd is committed to exceptional customer service, and therefore undertakes that any dispatch errors caused by Allstock Nominees Pty Ltd will be collected and credited without question. Allstock Nominees also understands that Applicant(s) are often asked to accept returns from their customers for a variety of reasons outside Allstock Nominees control. To this end we are happy to assist Applicant(s) by taking back standard stock line goods within a seven (7) day period, deducting a 25% re-stocking fee. If goods have been ordered from a Supplier specifically for the Applicant then Allstock Nominees Pty Ltd will not accept these goods for credit return. Goods are to be returned to Allstock Nominees, insurance and freight prepaid, along with a copy of the Original Purchase Invoice. Goods must be returned to Vantex complete (instruction manuals and keys) and in full resaleable condition - damage to, or markings on the original packaging may deem the products unsaleable, therefore the return claim will be rejected. A completed RA form must accompany returns.
20. Non-standard orders cannot be cancelled once placed with Allstock Nominees Pty Ltd and the Applicant must accept delivery of the goods within seven (7) days of Allstock Nominees Pty Ltd advising the Applicant of the availability of the goods for delivery.
21. Allstock Nominees Pty Ltd shall not be liable for indirect or consequential loss or damage suffered by the Applicant as a consequence of any action or in-action on the part of Allstock Nominees Pty Ltd.
